1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies

2. Statutory requirements

As we are a secondary academy school we must provide RSE to all pupils as per section 34 of the [Children and Social work act 2017](#).

In teaching RSE, we are required by our funding agreements to have regard to [guidance](#) issued by the secretary of state as outlined in section 403 of the [Education Act 1996](#).

At Queensbury School we teach RSE as set out in this policy.

3. Policy development

This policy will be developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

1. Review – a member of staff pulled together all relevant information including relevant national and local guidance
2. Staff consultation – all school staff will be given the opportunity to look at the policy and make recommendations
3. Parent/stakeholder consultation – The policy will be shared with parents and any interested parties and be available on the Queensbury School website.
4. Pupil consultation – we will investigate what pupils want from their RSE
5. Ratification – once amendments are made, the policy will be shared with governors and ratified

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

6. Delivery of RSE

RSE is taught within the Personal Development / SMSC education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE) and Life Skills.

The Loudmouth theatre in Education Company will deliver performances and workshops to all key stages to cover a range of Sex and Relationship Education issues through the programmes 'Safe and Sound', 'Trust Me', and 'Working for Marcus'.

'Trust Me' is a lively theatre in education programme that helps young people aged 13 upwards to learn about relationships and sexual health issues such as sexually transmitted infections, contraception, consent and unplanned pregnancy. The programme supports learners to understand the impact that unprotected sex can have and share ideas on how to create healthy, happy and safe relationships.

'Safe and Sound' promotes ways to raise confidence and knowledge of sexual health and raise awareness of local health services.

'Working for Marcus' is a powerful theatre in education programme on child sexual exploitation (CSE) including online sexual exploitation and abuse by individuals, organised groups or gangs. The programme includes workshops and lesson plans to provide a strong educational base that is informed by the research based drama.

The Umbrella Sexual Health team have created a SEN scheme of work and will deliver whole school training for staff to aid staff in delivery of the RSE curriculum

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- Intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

7. Roles and responsibilities

7.1 The governing board

The governing board will approve the RSE policy and hold the Executive Head Teacher to account for its implementation.

7.2 The Executive Head Teacher

The Executive Head Teacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from components of RSE (see section 8).

7.3 Staff

Staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Executive Head Teacher. All form staff at Queensbury School have a responsibility for teaching RSE in Queensbury School.

7.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

8. Parents' right to withdraw

Parents have the right to withdraw their children from the components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Executive Head Teacher.

A copy of withdrawal requests will be placed in the pupil's educational record. The Executive Head Teacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

9. Training

Staff are to be trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

The Executive Head Teacher will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

10. Monitoring arrangements

The delivery of RSE is monitored by the Head of Faculty for Personal Development through:

Planning scrutiny, lesson drop-ins and book scrutiny.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the Head of Faculty for Personal Development and SLT annually.

At every review, the policy will be approved by the governing board and the Executive Head Teacher.
